Who can Join?

Corporate Membership is open to any organisation who employs or manages a panel of experts.

There are two levels based on the level of vetting and quality assurance undertaken by the organisation.

Corporate Member	These organisations will be able to demonstrate that they check their experts' CV, proof of registration with their professional body, and provide professional indemnity insurance. They should also encourage their experts to engage in Continuing Professional Development. There must be a minimum of one EWI member on the management team.
Corporate Partner	In addition to the above requirements, Corporate Partners will be able to demonstrate that they check the quality and compliance of expert reports prior to the acceptance of an expert witness onto their staff/panel and have systems in place to keep staff panel members up-to-date as well as identifying, dealing with and resolving any issues and poor practice. There must be a minimum of one EWI member on the management team.

Profile, Status and Recognition

- Use of the EWI logo on your corporate website and letterhead
- Recognition of your role in assuring the quality of experts
- Organisation entry on the EWI "Find an Expert" directory on the EWI website
- Automatic admission to appropriate level of membership for your staff/panel members (depending on level of vetting undertaken by organisation)
- Member referral service Corporate member contact details made available to potential instructing parties
- Staff or panel members who are Full, Certified and Fellow Members
 can use the designated EWI Member logo and postnominals to
 indicate they have met the technical, legal and quality standards for
 EWI membership.

As an organisation, you will be expected to:

- Retain one named contact who will be a full member of the EWI
- Actively promote and encourage staff/panel members to become members of the EWI and attend events
- Have processes in place to ensure the quality of experts
 - A Corporate Member will demonstrate that they check their experts' CV, proof of registration with their professional body, and professional indemnity insurance and encourage them to engage in Continuing Professional Development
 - In addition to the requirements for Corporate Members a **Corporate Partner** will demonstrate that they regularly check the quality and compliance of expert reports and have systems in place to identify, deal with, and resolve issues and bad practice.
- Ensure staff/panel members meet the EWI's published standard for reports
- Ensure that the Corporate Member logo is only placed on your corporate website and letterhead. These are not to be placed on staff/panel member pages, CVs or other documentation. Staff/panel members who join as an Full, Certified or Fellow Member will be able to use the appropriate personal member logo.

As part of your application, organisations will need to provide

- Company details
- Information about the areas of expertise covered by the organisation and geographical coverage
- Details of your vetting and quality assessment procedures (as applicable to the category you are applying for).

Potential Corporate members and partners will be assessed to make sure they have the appropriate procedures in place for their package level.
